Mr. Lo is currently Chairman of The Chamber of Hong Kong Logistic Industry; member of Hong Kong Logistics Development Council; member of the Logistic Services Advisory Committee, Hong Kong Trade Development Council and member of the Executive Committee of Hong Kong Sea Transport and Logistic Association. Through this investment, the Company expected to leverage the extensive logistics experience of Mr. Lo and to tie in with the Company expansion plan in the logistic industry as well as accelerating the mass transit transportation ticketing project of the Company.
